EXCLUSIONS

Paintless Dent Repair (PDR) does not include dents larger than 4" in diameter, pre-existing damage, collision or environmental damage, broken paint or sharp creases, chrome or unpainted portions of the vehicle, chips, cracks or paint damage, dents where access is restricted due to bracing, double metal panels or other structural limitations, roof panels with a sunroof, moonroof or convertible hardtop, surfaces with matte paint finish, film or wrap application or hail damage.** Please consult your service contract for complete details on exclusions and limitations.

**Hail damage is covered up to \$1,000 in Florida.
